

Transportation Partners – Guidelines for Daily Truck Updates

Classic Harvest asks all Transportation Partners to provide <u>twice</u> daily emailed truck updates. For most of our partners, their TMS system can send an automated email at the time of their check calls. Streamlining truck updates allows us to grow and do more business with you.

Guidelines below and example attached

Truck Updates must include

- ALL Tendered loads
 - Future Pick up
- · On the Road
- Loads loading that day
- Delivering that Day*

Any loads with outstanding potential carrier claim (this is new requirement)

*Please keep delivered orders on update for one day confirming delivery

Email to: beontime@classicharvest.com ONLY do not add extra email addresses

Update email should include

- Searchable text in the body of email
- Classic Harvest number
- Rate
- Origin City and Destination City
- Ship Date, Delivery Date, Original Del Date
- Truck location including miles to destination and city name
- Once Empty note any rejection/clean bills
- Subject line should include "truck updates" and current date (new email each day)

Some Do Nots

- Do NOT send random emails throughout the day and night under the guise of "over communicating" please try to keep at all your info to twice daily updates.
- Do NOT enter a rate that is incongruent with pre-agreed quotes and expect to be paid this only holds up payment while we wait for a corrected invoice.
- Do NOT mark a truck "empty clean bills" when POD was signed short or damaged

Exceptions:

- Carriers with less than five loads tendered at one time once daily is fine.
- Carriers with loads moving less than 250 Miles are exempt from requirements for daily updates, but strongly encouraged to do so as it assists greatly in paying you faster.~~
